1.2 ACTION TAKEN REPORT ON THE DECISIONS OF NINETEENTH ACADEMIC COUNCIL MEETING

The Action Taken Report on the decisions of the Nineteenth Meeting of the Academic Council was noted by the Council. However, the Council opined the following:

- (i) To enhance the weightage of SEE component for computation of CO attainment from the existing 20%. After deliberations, the same shall be enhanced to 30%.
- (ii) To include the contribution from PSOs in addition to the POs in all Academic Audit formats.

(iii) With regard to Research Plan of graduates who left the portals of BMSCE, it was emphasized that the programs set targets for Alumni serving in various capacities (Administrative sector, Academic Sector, Research organization, Government organization, Core organization, National organization, Multinational organization etc.); and analyze the professional profile of Alumni to reform academic practices to help reach set targets. The targets are set based on survey from students who join the program, parents of the students joining the program and faculty.

2.1 STATUS OF ACCREDITATION (UG & PG PROGRAMS)

The Principal informed the Council that all eligible UG and PG programs are accredited by NBA. Programs having validity of accreditation till 30th June, 2022, have applied for reaccreditation, and submitted the SAR after approval of the Pre-Qualifiers. In response to the discussions, the following details are included:

- (i) The Six UG Programs (SNo. 7 to 12) submitted the Pre-qualifier for Cycle-1 in December 2021. The Pre-qualifier was approved during February, 2022 and the SAR submitted in May, 2022. The visit by NBA expert team is scheduled for 26th to 28th August, 2022.
- (ii) The revised format of the SAR in Second Cycle was available on NBA portal during February, 2022. Subsequently, the Pre-qualifiers for the Five UG Programs (SNo. 2 to 6) was submitted during March, 2022. After approval of the Pre-qualifiers, the SAR has been submitted to NBA on 21.06.2022.

The visit shall happen before December 2022 and hence, there shall not be lapse in the accreditation period.

2.2 STANDING OF BMSCE IN NIRF RANKING – 2022

The Principal informed the Council that the National Institutional Ranking Framework (NIRF) approved by Ministry of Education, Government of India releases Ranking of Institutions under various categories every year since 2016. The NIRF-2022 was announced by Honourable Education Minister, Ministry of Education on 15th of July, 2022.

The B.M.S. College of Engineering has been ranked 83rd amongst top 100 Engineering Colleges in the Country, 3rd in the State of Karnataka. The Management acknowledges the contribution of all stakeholders and the support & guidance of Academic Council Members for this recognition.

The External Council Members appreciated the NIRF Ranking of the Institution and wished further progress in subsequent years.

2.3 AUTONOMOUS STATUS OF BMSCE

The Principal informed the Council that the UGC has extended the Autonomous Status further for a period of 10 years based on accreditation by NAAC (Letter No. UGC Letter No.F.22-1/2022 (AC) dated 17th, February 2022). This recognition was extended owing to the institution securing highest grade in NAAC Cycle I & Cycle II. The Institution is awarded A++ Grade with 3.83 on a scale of 4 by NAAC.

Further, the Higher Education Department, Government of Karnataka has approved the extension of Autonomous Status (Letter No. ED 123TEC 2022 dated 22.06.2022).

Further, the University (VTU), has approved the extension of Autonomous Status from 2021-22 to 2031-32 (Letter No. VTU/BGM/Aca/A12/2021-22).

The External Council Members appreciated the extension of Autonomous Status of the College by 10 years.

2.4 INITIATIVES TOWARDS IMPLEMENTATION OF NEP-2020

The initiatives by the College towards implementing the NEP are as follows:

- Constitution of the Institutional Level NEP Committee towards implementation of NEP-2020.
- (ii) Dr. Leena Chandran Wadia, Former Senior VP and CTO Netcore Solutions Pvt. Ltd., Bengaluru and Academic Council Member, BMSCE delivered an online Guest Lecture on, "New Education Policy 2020" on 05th August 2020.
- (iii) Conduction of two day workshop on, "Implementation of NEP 2020" on 15th and 16th November 2021. The Honorable Vice-Chancellor, **Dr. Karisiddappa**, VTU graced the occasion and delivered the keynote address on, "Governance

practices on NEP 2020". The workshop included focused discussions by various BOS, VTU for evolving the first year Scheme and Syllabus under the NEP 160 credit structure.

(iv) The IQAC-BMSCE in association with NAAC organized a One-day National level online seminar on "Digital Transformations under NEP 2020" held on 15th July 2022. The program commenced with the keynote address by **Dr. K. Rajanikanth** on, "Importance of NEP-2020".

As per the VTU guidelines, the curriculum for first year under 160 credit scheme is effective from the academic year 2021-22.

In addition, towards implementation of the NEP, the Open Elective courses have been expanded to include electives from MBA program, MCA program and BMS Law College for students admitted 2018 onwards (students presently in the 3rd and 4th year of the Engineering program).

The Council Members appreciated the initiatives with regard to implementation of NEP-2020 through the curriculum.

2.5 REPORT ON STRATEGIC PLAN

The Vice Principal (Admin) presented the Strategic Plan of the Institution.

Dr. Satish V. Kailas suggested the inclusion of continuous improvement in performance of GATE as a Long Term Strategic Plan together with including measures for the same.

The external members appreciated the inclusion of GATE syllabus in the Curriculum together with inclusion of GATE type of questions in internal assessments of relevant courses. This process ensures students qualify GATE without any additional efforts beyond curriculum.

2.6 REPORT ON GOVERNANCE DOCUMENT

2.7 PRATHIBHOTSAVA – VTU YOUTH FESTIVAL

College of Engineering from the 29th to 31st of July 2022. The Fest witnessed the Cultural show from all over Karnataka, from across different Colleges under VTU.

2.8 SRISHTI – STATE LEVEL PROJECT EXPO AND COMPETITION

The Vice Principal (Academic) briefed about the prestigious 18th edition of Srishti 2022 – a prestigious State level Project Expo and competition organized by Vidyarthi Shikshana Seva Trust in association ABVP supported by VTU and hosted at BMS College of Engineering from 25th July 2022 to 27th July 2022.

The main objective of Srishti is to provide a platform for creative enthusiastic students and budding scientists and to give an insight in to the entrepreneurial avenues. It is also an effort to develop industry-institution interaction and bridge the gap between the contemporary needs of industry and the R&D on College premises.

Srishti 2022 was graced by dignitaries like Minister of Higher Education, GoK., Honorable Vice Chancellor – VTU, Chairman – ISRO. The event showcased 217 projects, 20 parallel stream-wise events, from 113 engineering colleges from across Karnataka. A total of 1600 students, together with 150 jury from industry and research organizations participated in the event. Prizes worth Rs. 20 Lakhs were awarded to the winners.

2.9 SCHEME AND SYLLABUS OF FIRST YEAR (BATCH 2021-22 ONWARDS)

The First Year Scheme and Syllabus based on VTU guidelines, applicable for batches admitted 2021-22 onwards was presented by Dean Academics. The First Year Scheme and Syllabus is based on VTU First Year Scheme and Syllabus. The course content of most of the courses are similar to that of VTU, however the Course Outcomes and the Assessments are designed to address the POs (including higher order POs).

The Council ratified the First Year Scheme and Syllabus.

2.10 CURRICULUM FOR UG PROGRAMS – 160 CREDIT SCHEME

The Dean Academics presented the process adopted to frame the Curriculum for the UG program, under the 160 credit scheme, for Batches admitted 2021-22 onwards, for III to VIII semester. The Curriculum includes various curricular components to ensure overall development of students, with equal emphasis on Program Core as well as courses for holistic development as envisaged by the NEP.

The proposed Credit distribution evolved through series of discussions with HODs and Deans Council is as below:

- 20 credits for First and Second Semester
- 22 credits for Third to Sixth semester

- 16 credits for Seventh and Eight semester
- The curriculum includes provision for Eight semester students to take-up Internships for five days a week and attend College on Saturdays.

The salient features of the Curriculum are:

- Program Core to include courses recommended by
 - o AICTE Model Curriculum
 - o VTU Core
 - o Program Specific Criteria by ABET
 - Courses of competitive examinations like GATE/CAT
- Program Electives to be offered in identified stream / specialization / Thrust area of the program/computing skills.
- Open Electives to be offered in AICTE Thrust areas/ identified stream, including Sciences, Law and Management. The curriculum provides an opportunity for students from conventional engineering programs to take open electives from emerging areas.
- Projects: The Curriculum includes independent projects from 5th Semester onwards. In addition, few courses of the curriculum have small projects being implemented through the Alternate Assessment Tool of the course.
- Internships: Students are expected to complete minimum three Internships during the program of 16 weeks duration.

- o First Internship is of 2-4 weeks duration with NGO / Social Activity implemented during semester break after 2nd or 3rd semester and evaluated through seminar and report in the 4th Semester.
- Second Internship is of 4-6 weeks duration with Industry / Academic institution implemented during semester break after 4th or 5th semester and evaluated through seminar and report in the 6th Semester.
- Third Internship is a running internship during the 8th semester of 10-12 weeks duration with Industry / Academic institution / Research organization and evaluated through seminar and report in the 8th Semester.
- Ability Enhancement Courses on:
 - o Innovation and Design Thinking
 - o Scientific Foundation of Health
 - o Universal Human Values
 - o Engineering Mathematics concepts using Python in second year
- Typical Humanities Courses on:
 - o Communicative English
 - o Professional writing skills in English
 - o Constitution of India, Professional Ethics and Human Rights
 - o Samskrutika Kannada / Balake Kannada
 - o Environmental Studies
 - Project Management and Finance

After the detailed deliberations, the observations made by the Council is as follows:

- The Council appreciated the inclusion of GATE syllabus through core courses of the curriculum together with the inclusion of GATE type of questions in the internal assessments wherever applicable.
- **Dr. Sathish V. Kailas** appreciated the introduction of Engineering Mathematics concept using Python as an Ability Enhancement Course in the 2nd Year.

- Mr. Aravind Kamath emphasized the need to include Multi-disciplinary Projects through the Curriculum with credit.
- Dr. K. Rajanikath emphasized the need to distinguish the Internship and Project components being implemented simultaneously during the 8th semester.

He also opined that MOOCs may be included in the Curriculum with Credits and not as a Non-Credit course, since the efforts by the students in clearing MOOCs offered by SWAYAM / NPTEL with proctored exam is significant.

The Humanities course "Constitution of India, Professional Ethics and Human Rights" includes three major areas with only 1 credit.

The Council appreciated and approved the proposed Curricular Structure for 160 credit scheme.

2.13 REPORT ON B.E. HONORS

The Controller of Examinations presented details of the B.E. Honors program initiated by VTU for interested and eligible students. Students need to earn additional 18 credits through online SWAYAM / NPTEL platform and successfully complete proctored exam (four weeks of online course is equivalent to 1 credit) and maintain a CGPA greater than 8.5. Eligible and interested students can register for the B.E. Honors program during their 5th semester.

Number of student applied for B.E. Honors program from batch admitted 2018-19 is 96. Number of student applied for B.E. Honors program from batch admitted 2019-20 is 19.

2.15 PLACEMENT STATISTICS

The Placement Officer informed the Council that the quality of On-campus placement has witnessed continuous improvement. It is gratifying to note that the quality and quantity of On-campus placements did not get affected due to pandemic. This is because of the joint efforts by the departments in Teaching Learning Process together with continuous additional training from placement office.

The Council appreciated the Average pay package of 10.9 LPA with a median of 9.25 LPA together with Highest Pay package of Rs.32 LPA and 80% of students securing on-campus placements.

3.2 PART-TIME UG ENGINEERING PROGRAM

The Principal informed the Council that the B.M.S. Evening College of Engineering (BMSECE) was started during 1972-73 under BMS Educational Trust by late Sri. B.S. Narayan, a Philanthropist. It was started with due approval from the Government towards imparting part-time degree courses for employed diploma holders in Engineering as a Social responsibility. The College offers five undergraduate Engineering programs (CV, ME, EE, EC & CS). The admission are done as per the guidelines of DTE / KEA.

As per the AICTE letter dated 03.05.2021, it is mentioned that the AICTE policy introduced in 2020-21, AICTE has discontinued the First Shift/Second Shift/Part-Time and AICTE now will permit the Colleges to run the Programs only as Regular Programs (4 years). For the academic year 2021-22 a total of 196 students were initially admitted for the 1st year Autonomous stream of BMS College of Engineering. The students placed a representation for considering their admission to 2nd year of the Engineering program.

As per the AICTE letter F.No.AICTE/AB/SWR/2020/BMSECE/2021 dated 06.06.2022, as a onetime exception in the interest of 196 students admitted to B.E. approval was accorded to the students for the academic year 2021-22 by AICTE under lateral entry to 2nd year/3rd Semester.

Further, as per the directions of the VTU vide letter No. VTU/BGM/SA-Aca/2022-23/2136 dated 13.07.2022 the admission of 196 students allotted by KEA is considered under Autonomous scheme to the 3rd semester of the Engineering program for the academic year 2021-22. The administration and academic responsibility shall be with the Principal, BMS College of Engineering, Bull Temple Road, Bangalore.

In view of the above, the Academic Calendar for students pursuing the Part-time Engineering program is prepared such that the students shall complete their 3rd and 4th semester and take-up the SEE of 5th semester along with the Regular students of BMSCE.

The External Council Members noted the matter and wished the students complete the program successfully.
