MANDATORY ACCREDITATION OF PROGRAMMES/ COURSES IN AICTE APPROVED INSTITUTES

It is brought to the notice of all AICTE approved institutions that the Council, in exercise of the power conferred under sub-section (1) of Section 23 read with Section (10) of the All India Council for Technical Education Act, 1987 has notified "All India Council for Technical Education (Mandatory Accreditation of all Programmes / Courses in Technical Education Institutions and University Departments and Institutions Deemed to be Universities Imparting Technical Education) Regulations, 2014" and the same was got notified in the Gazette of India vide Notification No. 37-3/Legal/AICTE/2014 dt. 29.01.2014. The objective of the aforesaid Regulations is to make all stakeholders aware that Accreditation of Programmes / Courses is an important tool to maintain quality of education and research and for its effective dissemination amongst stakeholders of the standards thereof.

Further to the above notification, it is also informed to all Institutions that the expansion of capacity and addition of new courses in the AICTE approved technical institutions has been allowed only for NBA accredited institutions from the academic year 2015-16 and the same has also been continued for the academic year 2016-17. Accordingly, the relevant clauses have been notified in the Approval Process Handbook, 2016-17.

Keeping the above in view, all AICTE approved institutions are encouraged to apply and get their programmes/courses accredited from NBA, in order to maintain quality of education & research and for further expansion of the capacity of the existing courses as well as for the introduction of new courses.
