And At least total of 6 research publications in SCI / Scopus journals approved list of journals. And Minimum of 8 years of experience in teaching/research/industry out of which at least 2 years shall be Post Ph.D. experience.

Assistant Professor:	The minimum qualification required is as per AICTE Norms, preference will be given to the candidates with Ph.D qualification, candidates who have registered for Ph.D can also apply.
Associate Professor:	Ph.D degree in the relevant field and First Class or equivalent at either Bachelor's or Master's level in the relevant branch. And At least total of 6 research publications in ABDC/Scopus indexed/UGC/Pear reviewed unpaid journals. Post Ph.D publication and guiding Ph.D students is highly desirable. And Minimum of 8 years of experience in teaching/research/industry out of which at least 2 years shall be Post Ph.D. experience.

Assistant Professor:	The minimum qualification required is B.Sc (Statistics) and M.Sc (Statistics) or B.Stat and M.Stat with Ph.D degree in concerned/allied disciplines. The candidates who have completed Ph.D Viva Voce may also apply.
